Abstract:

Based upon the proposed construction of the Perry Reservoir on the Delaware River in northeastern Kansas, the results of which would eventually inundate numerous archaeological sites along its length, a memorandum of agreement between the University of Kansas and the National Park Service was drawn up which provided for archaeological investigations within the reservoir area (quoted from Perry Reservoir final report, 1968).

Working in 1965, a crew from the University of Kansas visited sites in the southern portion of the reservoir area and concentrated their excavations along Big Slough and Evans Creeks. The work was directed by Carlyle S. Smith and supervised by graduate student Jack M. Schock.

Carlyle Smith's directorship of this project led to the collection of these manuscript materials, which include project correspondence, site feature forms, ceramic data and tabulation, Jack Schock's supervision field journal, media clippings, maps, and photograph logs.

Biographical Name: Carlyle S. Smith

Biographical Note: Carlyle Smith was born in 1915 in Great Neck, New York. He received his PhD from Columbia University where he trained under William Duncan Strong and was initially exposed to Plains archaeology. He joined the University of Kansas faculty in 1947 as an assistant professor with the Department of Anthropology and Sociology and assistant curator with the Natural History Museum. His fieldwork spanned 1938 to 1975 and included investigations in New York, South Dakota and Kansas, Easter Island and the Marquesas. Carlyle Smith's fieldwork and research significantly added to the collections at KU while his contribution to teaching prepared many students for a professional career in Anthropology. His leadership was a significant contribution to the development of a separate department of Anthropology in 1962 and the creation of the Museum of Anthropology in 1976.

Scope and Contents:

As Carlyle Smith was the director of this project, the materials collected here are of a managerial nature.
